Qualified Drawn Entrant:	Qualified Entrant whose Qualified Entry is drawn by Gateway in accordance with these Promotion Terms.
Draw Prize(s):	A prize awarded to a Qualified Drawn Entrant as a result of a Draw (as described above).

How to Enter:

MCR EQD Procedure:

11. Shortly prior to Draw Time on each Draw Date within the Promotion Period, a Gateway employee or site designate may give a warning that the EQD drum is closing and for Qualified Entrants to activate their Qualified Entries in order to allow the Draw process to take place.
12. At each Participating Facility, one (1) Guest Services employee or site designate (the “Drawer”) will conduct the Draw following Gateway's EQD procedures.
13. Qualified Drawn Entrants will be selected from the activated Qualified Entries.
14. The Drawer will announce over the Participating Facility’s public announcement system the first name, last initial, and MCR account number of the Qualified Drawn Entrant immediately after the Draw.
15. All activated Qualified Entries will be removed from the EQD drum following the Qualified Drawn Entrant’s claiming of a Draw Prize for that Draw and must be re-activated during the Qualification Period for a subsequent Draw in order to be eligible to win a Draw Prize for that subsequent Draw

How to Claim a Draw Prize:

Qualified Drawn Entrants must be Present to Win:

16. Qualified Drawn Entrants must be present at the Participating Facility to claim the Draw Prize. Qualified Drawn Entrants selected will have five (5) minutes to present themselves to a Gateway employee at the Guest Services Front Desk of the Participating Facility to claim the Draw Prize.
17. If, at the time of the Draw and after the announcement of the Qualified Drawn Entrant is made, the Participating Facility is at legal capacity that prevents a potential Qualified Drawn Entrant from entering the building, the Qualified Drawn Entrant must declare themselves the winner to a Gateway employee within the five (5) minute claiming period but does not have to present themselves to the Guest Services desk or draw area within the claiming period. Once declared, the potential winner will be vetted by a Guest Services representative to validate the winning Qualified Entry.
18. If the Qualified Drawn Entrant does not present themselves to a Gateway employee within five (5) minutes of the Draw, the Qualified Drawn Entrant will be disqualified, and the Drawer will select an alternate Qualified Drawn Entrant.  - b. System Malfunction:
