Promotional Scratch & Win Card How To Win:

17. To qualify for prize reimbursement, a Qualified Entrant must scratch SIX (6) AND ONLY SIX (6) surfaces on a Promotional Scratch & Win Card revealing identical winning “Jewel” symbols (in any rotation) under each and every scratched surface. For greater certainty, if a Qualified Entrant scratches less than six (6) or more than six (6) surfaces on a Promotional Scratch & Win Card , the Qualified Entrant will not be eligible for a prize even if the Promotional Scratch & Win Card is a winning Promotional Scratch & Win Card .

Submitting a Claim for the \$100,000 US Insured Promotional Scratch & Win Card Prize

25. Gateway Corporate Marketing to be notified immediately by a Participating Facility Guest Services employee of any Promotional Scratch & Win Card that a Qualified Entrant successfully matches six (6) “Jewel” symbols.
26. Immediate telephone notice by Gateway to the claims department of Prize Supplier will be reported no later than the first business day after a winning Promotional Scratch & Win Card is claimed.
27. Gateway must provide all winning Promotional Scratch & Win Cards to the third party designated by Prize Supplier for verification. The eligibility of a winning Promotional Scratch & Win Card will be judged by the sole and absolute discretion of Prize Supplier and/or the designated third party.
28. Proof of Claim: The following items and completed documentation will be furnished to Prize Supplier as proof of a prize claim (forms to be furnished by Prize Supplier): (a) Affidavit of Promotion Official; (b) Affidavit of Winner; and (c) Untampered with winning Promotional Scratch & Win Card.
29. Investigation: Upon receipt of Proof of Claim, OOP may conduct a reasonable investigation as a condition to payment of the claim if, in the sole opinion of Prize Supplier such an examination is warranted by the facts.
30. Once a Promotional Scratch & Win Card has been verified as a winner, and all other contract provisions have been satisfied, Prize Supplier will issue reimbursement of the prize.
31. NOTE: If the Promotional Scratch & Win Card has been tampered with in any way, the claim will be denied. Only the designated number of squares may be scratched off, in whole or in part, or the claim will be denied.
32. Once a Qualified Entrant is declared a winner by Prize Supplier, Prize Supplier will provide payment to Gateway in USD. The Qualified Entrant will be notified within seven (7) days of Gateway receiving payment and will be given the option to receive payment in either American or Canadian funds. SCA PrizePro Kiosk Draw Procedure:

34. Shortly prior to Draw Time on each Draw Date within the Promotion Period, a Gateway employee or site designate may give a warning that the SCA PrizePro Kiosk is closing and for Qualified Entrants to activate their Qualified Entries in order to allow the Draw process to take place.
35. Odds of winning a Draw Prize are based on the total number of Qualified Entries that have been accumulated at each Facility throughout the Promotion Period and will vary by Facility.
36. On Draw days, all Qualified Entrants who have participated in the Promotion at a Facility will be afforded the opportunity to activate all Qualified Entries earned at that Facility that have accumulated throughout the entire Promotion Period by swiping their My Club Rewards card at a SCA PrizePro Kiosk four (4) hours prior to the Draw taking place.
37. At each Participating Facility, one (1) Guest Services employee or site designate (the “Drawer”) and witness will conduct the Draw following Gateway's SCA PrizePro Kiosk draw procedures.
38. Qualified Drawn Entrants will be selected from the activated Qualified Entries.
39. The Drawer will announce over the Participating Facility’s public announcement system the first name, last initial, and MCR account number of the Qualified Drawn Entrant immediately after the Draw.
40. All activated Qualified Entries will be removed from the SCA PrizePro drum following the Qualified Drawn Entrant’s claiming of a Draw Prize for that Draw and must be re-activated during the Qualification Period for a subsequent Draw in order to be eligible to win a Draw Prize for that subsequent Draw.

How to Claim a Draw Prize:

41. Qualified Drawn Entrants must be present at the Participating Facility to claim the Draw Prize. Qualified Drawn Entrants selected will have five (5) minutes, except Casino Rama Resort Qualified Drawn Entrants will have ten (10) minutes to present themselves to a Gateway employee at the Guest Services Front Desk of the Participating Facility to claim the Draw Prize.
42. If, at the time of the Draw and after the announcement of the Qualified Drawn Entrant is made, the Participating Facility is at legal capacity that prevents a potential Qualified Drawn Entrant from entering the building, the Qualified Drawn Entrant must declare themselves the winner to a Gateway employee within the five (5) minute claiming period but does not have to present themselves to the Guest Services desk or draw area within the claiming period. Once declared, the potential winner will be vetted by a Guest Services representative to validate the winning Qualified Entry.
43. If the Qualified Drawn Entrant does not present themselves to a Gateway employee within five (5) minutes of the Draw, the Qualified Drawn Entrant will be disqualified, and the Drawer will select an alternate Qualified Drawn Entrant. Draws will continue until the Draw Prize is claimed in accordance with these Promotion Terms.
44. Before the Draw Prize will be issued to the Qualified Drawn Entrant, the Qualified Drawn Entrant must present valid government-issued photo identification to a Gateway employee at the Guest Services Front Desk of the Participating Facility verifying their identity.
 - a. If the Qualified Drawn Entrant is unable to present identification at the time of the Draw, the Qualified Drawn Entrant may verify their account by correctly answering the following MCR account related information: address, phone number and date of birth.
 - b. If the Qualified Drawn Entrant correctly verifies their account information, the Draw Prize can be considered claimed, but will not be awarded until the Qualified Drawn Entrant returns with valid government-issued photo identification. All Qualified Drawn Entrants who claim a Draw Prize using this method must return to the Participating Facility with valid government issued photo ID within forty-eight (48) hours or the Draw Prize will be forfeited.
 - c. Qualified Drawn Entrants will be required to complete the applicable prize acknowledgment and/or release forms in the presence of one (1) Gateway employee.
45. All Qualified Entries selected as winners and/or alternates will not be placed back into the SCA PrizePro Kiosk drum to be eligible for selection in upcoming Draws.

System Malfunction:

46. In the event of a technical issue with the SCA PrizePro Kiosk system at the time of the Draw, the Drawer will continue to attempt to conduct the Draw for up to thirty (30) minutes following the Draw Time. Announcements will be made informing Qualified Entrants that due to technical difficulties, the Draw will be delayed for approximately thirty (30) minutes.
47. If after thirty (30) minutes the SCA PrizePro Kiosk system has not restored, the Drawer or another Gateway employee at the Participating Facility will advise Qualified Entrants that the Draw will take place once the SCA PrizePro Kiosk system has been restored and Qualified Entrants are not required to be present to win.
48. The Drawer or another Gateway employee at the Participating Facility will conduct the Draw(s) once the system is restored and will contact the Drawn Qualified Entrant(s) via their preferred method of contact as recorded in the CMP database, once the Draw has been completed.

No Purchase Necessary:

49. Qualified Entrants may receive a Qualified Entry in the Promotion without purchase by writing a short Two Hundred & Fifty (250) word essay stating "What their favourite winter activities are in the month of February" Upon completion of such essay, the Qualified Entrant must bring the completed essay to the Guest Services Desk within the Qualification Period on the Draw Date. If the essay is complete, as determined by a Gateway employee in their sole discretion, a Guest Services supervisor, manager or Participating Facility designate of Gateway, will award five (5) Qualified Entries to the Qualified Entrant
